THE COUNCIL OF THE CITY OF COOKEVILLE, TENNESSEE HEREBY ORDAINS:

SECTION I: That the Cookeville Municipal Code is hereby amended by deleting Section 18-121 in its entirety and substituting in lieu thereof the following:

Effective May 1, 2019 – Rates for users of water within the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge)

\$5.10 Minimum Bill

All gallons over zero usage

\$3.30 per 1,000 gallons

Effective May 1, 2019 – Rates for users of water outside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge)

\$7.65 Minimum Bill

All gallons over zero usage

\$4.95 per 1,000 gallons

Effective May 1, 2020 – Rates for users of water inside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge)

\$6.10 Minimum Bill

All gallons over zero usage

\$3.56 per 1,000 gallons

Effective May 1, 2020 – Rates for users of water outside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge)

\$9.15 Minimum Bill

All gallons over zero usage

\$5.34 per 1,000 gallons

Effective May 1, 2021 – Rates for users of water inside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge)

\$7.10 Minimum Bill

All gallons over zero usage

\$3.65 per 1,000 gallons

Effective May 1, 2021 – Rates for users of water outside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge) All gallons over zero usage \$10.65 Minimum Bill \$5.48 per 1,000 gallons

Effective May 1, 2022 – Rates for users of water inside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge) All gallons over zero usage \$8.10 Minimum Bill \$3.79 per 1,000 gallons

Effective May 1, 2022 – Rates for users of water outside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge) All gallons over zero usage \$12.15 Minimum Bill \$5.69 per 1,000 gallons

Effective May 1, 2023 – Rates for users of water inside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge) All gallons over zero usage

\$9.10 Minimum Bill \$3.82 per 1,000 gallons

Effective May 1, 2023 – Rates for users of water outside the corporate limits of the City of Cookeville shall be as follows:

Zero Usage (Base Charge) All gallons over zero usage \$13.65 Minimum Bill \$5.73 per 1,000 gallons

Water Storage Rate Effective July 1, 2009 – Water storage rate for users of water within and outside the corporate limits of the City of Cookeville shall be as follows:

Each 1,000 gallons per month

\$0.19 per 1,000 gallons

The cities of Baxter and Algood, and all utility districts shall pay rates as established by contract with the city of Cookeville (see section 13-126).

The rates listed above are net. In the event that any bill is not paid within fifteen (15) days from the date of the bill, there shall be added to the bill an amount equal to five percent (5%) of the bill. To any amount remaining unpaid thirty (30) days after the date of the bill, there shall be added a penalty of one percent (1%), and an additional one percent (1%) shall be added at the end of each successive thirty (30) day period until the amount is paid in full.

ORDINANCE

SECTION II: That the Cookeville Municipal Code is hereby amended by deleting a portion of Section 18-208(3) entitled "Sewer Rates – Effective October 1, 2013, Chapter 2 of Title 18 and substituting in lieu thereof the following:

Effective May 1, 2019 – Each residence and place of business within the corporate limits of the City of Cookeville, Tennessee, shall pay the following rates per 1,000 gallons:

Zero Usage (Base Charge)

\$7.05

All gallons over zero usage

\$4.92 per 1,000 gallons

Effective May 1, 2020 – Each residence and place of business within the corporate limits of the City of Cookeville, Tennessee, shall pay the following rates per 1,000 gallons:

Zero Usage (Base Charge)

\$8.60

All gallons over zero usage

\$5.46 per 1,000 gallons

Effective May 1, 2021 – Each residence and place of business within the corporate limits of the City of Cookeville, Tennessee, shall pay the following rates per 1,000 gallons:

Zero Usage (Base Charge)

\$10.15

All gallons over zero usage

\$6.15 per 1,000 gallons

SECTION III: This Ordinance shall take effect fourteen (14) days from and after its final passage, the public welfare requiring it.
