Originally constructed in 1946 by Mabel H. Russell in a style possibly inspired by Art Moderne architecture, the home has undergone a series of renovations both in function and architectural style. In September of 1949 the home was purchased by Hazel Elrod mother of Sally Davis, grandmother of Maggie Anderson. The Davis family saw the opportunity to board as many as twelve young men that were in attendance at Tennessee Technological University (TTU). The initial layout of the structure was a duplex apartment on the main floor with an additional four rental rooms on the second level.

After Sally's passing the home was sold to Isaac Zuercher, a custom home builder, in December of 2006. While continuing to rent rooms to TTU students, Isaac undertook a large scale renovation transforming the home's exterior elevation to its current French Eclectic style in 2009. Subsequent renovations by the owner have included a complete rebuild of the main floor layout, addition of a bonus room on the second level and a screened living area in the rear of the home.
